State of Pennsylvania County of York 11

On this 5th day of November 1832

Personally appeared in Open Court Before the Court of Common Pleas now sitting at York in the State of Pennsylvania Leander K. Severly the Resident of said County of York in the State of Pennsylvania Aged 71 years who being first duly sworn according to Law doth on his oath make the following declaration in order to Obtain the benefit of an Act of Congress passed June 7th 1832

That he was drafted in Piddle Township in the County of Berks Pa about the first of July 1776 in Captain - Michael Wolf's Company in the Regiment commanded by Col Christian Louney for five months and marched through - Reading from thence to Carlisle on the Delaware River from thence crossed that River marched through Princeton in New Jersey and to Lanby and to "Penswick" and served three months and five days, being one month and five days more that the former he was drafted and was then discharged at Lanby in the State of New Jersey by Captain Wolf

That he was again drafted in Berks County in the State before said about the 1st of September 1777 in Captain Jacob Robinson's Company for two months in the Regiment commanded by Colonel Heister, and marched through Reading to one from thence to Buttsburg near the Schuylkill river, toward Germantown and encamped about four Miles from Germantown, for a short time, and remained thereabouts until the Battle of Germantown was fought in the Battle of Germantown, after the Battle was over he marched up the Country toward - Reading, and remained there a few days, then marched down the Schuylkill river again, a short distance and remained in Clear Springtown on the Schuylkill river until he was discharged near that place about twenty five miles from Philadelphia, and that he served three months on that

Expedition and was then discharged near Peristerow by Captain Rhears

and that he served three months ^{in the} under Captain Wolf in the Year 1776 as aforesaid and three months under Captain Rhears in Col Heister's Regiment in the year 1777

and that he served altogether six months at least in the Army of the Revolution,

and I further declare that I have no documentary Evidence in my possession nor do I know of any person now living whose testimony I can procure to prove my service thereby to request every Claim whatever to a pension or Annuity except the present and that that my name is not on the pension Roll of the Agency of any State whatever

Question by the Court 1 Where and in what ^{you} place was you born

Answer I was in the year 1768 in the County of Berks in the State of Pennsylvania

Question by the Court 2 Have you have you any Record of your age and if so where is it

Answer I have no record of my age

Question by the Court 3 Where were you living when called into service

Where have you lived since the Revolutionary war and where do you now live

Answer I was born in Berks County as heard and was called into Service where I lived twenty one years after the Revolution at which time I moved into York County where I have lived ever since

Question by the Court 4 How were you called into Service were you drafted did you volunteer or were you a Substitute and if a Substitute for Whom

Answer I was drafted

Question by the Court 5 State the names of some of the Regular Officers who were with the troops whom you served and such Continental and Militia Regiments as you can recollect and the general circumstances of the case

Answer - - I was acquainted with a Captain (McLean) of the Regular Army and Captain Livingston. I was acquainted with Col. Linn & Col. Hartshorn and was also acquainted with Capt. Riggs and Captain Wolf & Capt. Schenck.

Question by the Court 6 Did you ever receive a discharge from the service and if so by whom was it given and what has become of it

Answer - - I received two Discharges one signed by Capt. Wolf and the other by Captain McLean under whom I served which discharges I have lost.

Question by the Court 7 State the names of Persons to whom you are known in your present neighborhood and who can testify as to your Character for tranquility and their belief of your services as a Soldier in the Revolution

Answer - - John Jacobs Peter Waggomer Georg Livingstone Benjamin Deal & Samuel Harpold all of whom I am well acquainted with are my present neighbors who can testify to my Character for tranquility and their belief of my services as a Soldier in the Revolution I sworn to and subscribe the day and year

Dear Sir:

Reference is made to your letter in which you request the Revolutionary War record of Ludwig Swartz, of York County, Pennsylvania, who served in that war and received a pension.

The data which follow were obtained from the papers on file in pension claim S. 23446, based upon the military service in the Revolutionary War of Ludwig Swartz.

Ludwig Swartz was born in 1761, in Berks County, Pennsylvania. The names of his parents are not shown.

While residing in Pottsville (probably meant for Bethel) Township, Berks County, Pennsylvania, Ludwig Swartz enlisted about July 1, 1776, and served three months and five days as a private in Captain Michael Wolf's Company, Colonel Christian Lovers's Pennsylvania Regiment; he enlisted again about September 1, 1777, served three months in Captain Jacob Rehner's Company, Colonel Elister's Pennsylvania Regiment and was in the battle of Germantown.

After the Revolution, he continued to reside in Berks County, Pennsylvania, for twenty years, then moved to York County, that state.

He was allowed pension on his application entered November 5, 1832, while residing in York County, Pennsylvania. He signed in German, Ludwig Swartz, was borne on the pension roll as Ludrick Swartz.

There are no data as to soldier's family.


