Mr. SEAMAN, from the Committee on Revolutionary Pensions, re-
ported the following bill :

A BILL

For the relief of Catharine Fulton, of Washington county, Penn-
sylvania.

1 Be it enacted by the Senate and House of Representatives
2 of the United States of America in Congress assembled, That
3 the Secretary of War be, and he is hereby, authorized and re-
4 quired to place the name of Catharine Fulton upon the revolu-
5 tionary pension roll, under the acts of seventh July, eighteen
6 hundred and thirty-eight, and third March, eighteen hundred
7 and forty-three, for twelve months' service as a captain in the
8 revolutionary army, as the widow of Captain Samuel Fulton,
9 and that her pension commence the first January, eighteen hun-
10 dred and forty-five.

Hon. J. G. Edwards,

I have the honor to enclose you some additional evidence in reference to the purchase claim of my grandmother Catherine Sutton. I made a good deal of inquiry about the character of the witnesses, and always heard them highly spoken of. I have believed the claim to be so good that I have spent much time and money in trying to establish it, and hope that the evidence I send you will authorize you to allow her a pension, and as the claim has been on hand a long time, I would request that you would forward your decision immediately ^{to my} ~~at~~ ^{my} Taylorsville Kentucky. I called to see one George Pullin yesterday, but he was dead, died on last Monday night, he was in the service a long time and drew a pension of 96 dollars per annum, and the gentleman and several of the family told me they had often heard him speak of Captain Sutton, and he would be surprised that he heard him speak of Captain ~~Sutton~~ ^{my} not more than three weeks since.

On this twenty fifth day of April 1838 one thousand eight hundred & forty four, personally appeared before the Subscriber a Justice of the Peace in & for the County of Washington, Catherine Fulton, a resident of South Conneshut in the County of Washington & State of Pennsylvania, aged eighty two years, who being first duly sworn, according to law, doth on her oath make the following declaration, in order to obtain the benefit of the provisions made by the act of Congress, passed July 4, 1838, entitled, an act granting half pay & pensions to certain widows: That she is the widow of Samuel Fulton, who was a captain of the Militia at one time, & I think of the Pennsylvania Troops, or Volunteers, or of the State Line. I cannot now remember of which, I believe he was in the wars about six years, he was in the battle of Long Island at which engagement he was wounded through the body, or else at the battle of Brandywine, not certain which he was at both these battles he was at the battle on Staten Island, & marched from thence to the White Plains by the order of Genl Washington or General Putnam, he was also out in the Indian Wars; at one of the places up on the river Susquehanna, called Shamokin, where he recd a wound in the knee, he was at a place called the "Queens Palace", where he & his men took from the English & Indians a large quantity of furs & other booty, he was also engaged in guarding the boats at Camp Security in York County, in 1787, or '2, in York County Penn^a, I am sure for four months & perhaps more. I know of his services at that time, I once remembered many more particulars, but have now forgot them, I have ~~not~~ frequently seen my husband's commission & have find it in my possession, until about 1831, when Robert Fulton (who is since dead) took it to Washington, Pa when it was lost, & I know not what has become of it - she further declares that she was married to the said Samuel Fulton, on the fifth day of May one thousand seven hundred & eighty five, that her husband, the aforesaid Samuel Fulton died on the thirteenth day of May one thousand eight hundred & twenty one, that she was not married to him prior to his leaving the service, but the marriage took place previous to the first of January, 1794 - at the time above stated - sworn & subscribed on the day & year above written, before me -

J. W. S. Cobb a Justice of the peace in and for the County aforesaid, do hereby certify that the foregoing declaration in the matter of the application of Catharine Fulton for a pension was made in person before me. That the applicant declared that she could not from age & bodily infirmity appear in open court for that purpose - & in my opinion I do fully concur & say that she is wholly unable to travel the distance, which she would have to do. Which is about twenty two miles to the County Seat: and if in my opinion after the investigation of the matter & after putting the interrogatories prescribed by the War Department that Catharine Fulton is the wife of Samuel Fulton who served in the Revolutionary War as stated by her, and the said Justice further certifies that it appears to him that Catharine Fulton who has signed the preceding declaration, was never married since the death of her said husband Samuel Fulton that she is entitled to full credit, and that she is a pious & good woman. Dear Madam:

You are advised that it appears from the papers in the Revolutionary War pension claim, No. 2783, that Samuel Fulton enlisted some time in 1776 in York County, Pennsylvania, and served one year as lieutenant and the balance of the time as captain in the Pennsylvania troops, length of service about six years. During this service he was in the battle of Long Island, where he received a wound in his body, in the battles of Brandywine and Staten Island, capturing fifteen Hessians in the latter battle. In 1779 and 1780, he fought against the Indians on the Susquehanna River and was shot on the knee at Shesokin. In 1780 and 1781, he was in North and South Carolina under General Green in the battles of Hanging Rock, King's Mountain, Cowpens and Salisbury. From August 1781, he was at Camp Security, New York, for four months or longer.

o Soldier died May 13, 1821 in Washington County, Pennsylvania, at which time he was in his seventy-first year.

He married May 5, 1785, at Chanceford, Hopewell Township, York County, Pennsylvania, Catharine, or Catherine, Smith, daughter of Colonel Smith.

She was pensioned by Special Act of Congress approved August 5, 1848.

In 1844, she was a resident of Smith Township, Washington County, Pennsylvania, aged eighty-two years.

Their son, Robert Fulton, was living in 1831 but died before 1844. A son, a Presbyterian minister, was referred to in 1889. One Samuel Fulton, a Presbyterian minister, made affidavit in Allegheny County, Pennsylvania, in 1844 in behalf of the widow. A grandson, Samuel S. Fulton, was a resident of Taylorsville, Kentucky, in 1848.

Sir:

In reply to your letter dated the 22nd and received on the 24th instant, you are advised that Catharine Fulton, widow of Samuel Fulton, applied for pension April 25, 1844, while eighty-two years of age and residing with Thomas C. Arnold in Smith Township, Washington County, Pennsylvania.

It is alleged that Samuel Fulton served about six years in the Revolution, one year as Lieutenant and the rest as a Captain, during which time he was in the battles of Long Island, Staten Island, Brandywine, Valley Forge, Hanging Rock, Kings Mountain, Cowpens, Guilford and Salisbury; and that he sustained a wound through the body at the battle of Long Island or Brandywine, and a gunshot wound of knee in a skirmish with Indians at Shamokin on the Susquehanna river, and that from August, 1781, he was stationed at Camp Security, York County, Pennsylvania, for four months.

He married at Chancesford, Hopewell Township, York County, Pennsylvania, May 5, 1785, Catharine Smith, daughter of Colonel Smith.

Soldier died in Washington County, Pennsylvania, May 13, 1821, in the seventy-first year of his age, and his widow Catharine was pensioned

(Wid. File No. 2,783.) at \$240. per annum from January 1, 1845, by Special Act of Congress approved August 5, 1848.

Their son Robert is the only child referred to. Samuel S. Fulton a grandson, of Taylorsville, Kentucky in 1845, and Rev. Samuel Fulton (no kinship stated) testified in the case.

You are further advised that the above is the only Samuel Fulton of the Pennsylvania troops found on the Revolutionary War pension records, and that said records fail to afford any information in regard to David Fulton, Minitree Jones or James Wood, described by you.

His widow, Catherine, was granted a pension by Special Act of Congress, approved on August 5, 1848, for his services as a Captain in the Pennsylvania troops, but the details of such services are not definitely stated in any of the papers. In her petition the widow stated that she believed he was in the war for about six years; that he was in ^{the battles} ~~the battles~~ of Long Island and Brandywine, and in one of these battles received a wound through the body; that he was at the battle on Staten Island and marched from thence to White Plains; that he was also out in the Indian wars and while engaged in a battle at Shamokin was wounded in the knee; that he was also at a place called "Queen's Place", where he and his men took from the British and Indians a large quantity of furs and other booty; that he was also engaged in guarding the British prisoners at Camp Security, in York Co., in the year 1781, or 1782, for at least four months. One of the witnesses in the case stated that he personally knew of Capt. Fulton being in the service at least seventeen or eighteen months; that he was in command of a company and was engaged in the battles of Hanging Rock, Kings Mountain, and Guilford.

Before the subscriber a justice of the peace in and for the County
of Washington, personally appeared James Proudfoot of Hanover Township
Washington County, who being first duly sworn according to Law, deposes and
says: That I became acquainted with Samuel Fulton in York County State
of Pennsylvania, who came to that County from Northumberland County
where he had been engaged in a war against the Indians: This was about
the year 1779 or 80. - It was generally believed and never doubted, that
he had been a Captain prior to this period. - For when he was chosen
Captain, he could put his men thro' all their manœuvres in a manner
so much better than any other officer we had ever seen, it was
remarked that he was an experienced hand at the business, as others
had to use a book to direct them; in their military tactics, they kept
he had no need of. - He had been shot in the knee, before he came
to York County, which makes me believe that he had been in
some engagements, and I think he was a little lame from the
wound, the top of his knee was still loose - some time in the year
1787, about the beginning of August, I am sure he went out as
Captain of the militia to guard Burgoyne's prisoners at Camp
Security, I saw him in camp about the beginning of October
and knew him to be a Captain beyond a doubt. He and I
were very intimate, & he often told me little anecdotes - He told
at one time, before he came there - When in service up on the
river Susquehanna, that they had no way of conveying their baggage
the made a large dam across the river, then broke it open, & that by that
means got down the river, he was much beloved by his men, & had
the good will of all so much, that he was elected Captain, after that
moved away, out of honour & his memory. I saw this myself. He
was always considered a most reputable & truthful man. I know
him to be such, I know that this same Captain Samuel Fulton married
Catherine, the daughter of Colonel Smith - She was an old school mate
of mine - they were married by the Rev. Sherman, a minister of good &
regular standing, in York County, Hopewell Township, about the year 1785
and I know her to be the identical person, now applying for a pension to be
the legal & true wife & surviving widow of Capt. Samuel Fulton. I have good
reason to believe from every thing that I can gather that he was an
over

officer in the army for a number of years - I have lived for
 a great many years within three miles of Samuel Fulton, previous
 to his death, & have worshipped in the same church. I am a pensioner

McKennan have been returned to this office, and I have again examined the claim of Mrs Catharine Fulton, widow of Samuel Fulton. That he was a Captain of the Pennsylvania Militia, and performed some service, there can be no doubt; but the evidence is not satisfactory as to the length of that service. There is no positive proof that he served so long as six months. If we had such proof, we should not hesitate to allow a pension for that length of service. More direct evidence is required. The testimony of persons who served with him is required, and they should specify the length of each tour; the field officers under whom he served; the battles he was engaged in; and the posts or places where he was stationed, as well as the country through which he marched.

My dear Sir,

Washington Aug. 10. 1839

During the last winter Catherine Hutton the widow of Captain Samuel Hutton applied for a pension - Her counsel sent on the papers to me and they were handed over to the Department.

Whilst I was in Congress I utterly refused, for reasons which you can appreciate, having any professional concern in prosecuting claims before the Department. She has now applied to me as counsel to aid in having her claims prosecuted and there can be no impropriety in my engaging in the case.

The evidence was not, I believe, satisfactory and I would be glad to be informed whenever the proof is defective so that we may ascertain whether sufficient evidence can be procured to establish the claim. If not incompatible with the rules of the office I wd be glad to have a copy of the declaration and proof. I trust you know me well enough to believe that no improper use will be made of the papers.

The old lady is a very respectable woman and an idiot would not present a claim which she knew to be groundless - Her son ^{who} is a Presbyterian clergyman and worthy man says that he at one time showed me his father's commission (of Lt.) however, I have no recollection and his intention is that it was left with me - This was before the passage of any law in giving pensions to widows and I am satisfied he is mistaken about leaving it with me. Be this as it may, it seems the commission is lost and we must endeavor to supply the necessary proof.

Would you it violate your rules to examine the rolls of the Penna. line and see whether his name can be found - both

Hutton lived in York County and if he was in the regular army I suppose it must have been in the Penna. line.

Since the adverse report of
the Commissioner of pensions in the case
of Catherine Hutton I have had additional record
evidence from Harpersburg, which I herewith send
you, most carefully believing it will fully
and clearly establish the claim in question.
When at Wash. City I had an interview with
Col. Edwards, and thought where justice and
mercy united to plead the widow's cause
he would lend a listening ear. But Mr.
A most just, clear, and righteous claim has
been rejected. I have proven most clearly
a term of six months service by a very worthy
lady, and to corroborate the facts stated
by her, and convince the Com. I refer her
to any correct history of the Campaign.
By another witness a term of two or three
months, by another a term of four or five
months, by the three records of different
dates six or eight months, besides the unusual
amount of circumstantial evidence, of his
being wounded two or three different times.

The Auditor General at Harrisburg is con-
vinced, by his records, that I have need
sufficient evidence from that office to
establish the claim. But I will leave this
matter in the hands of the Law. I know
that the testimony and records I have
sent are amply sufficient according
to the regulations of the Department,
which I have before me, to entitle the
applicant to a captain's full pay.

We very often conversed together about his services, as an Officer
in the revolutionary War, and knowing him to be an excellent and
truthful man, I would have no doubt about the truth & correctness
of his statements. And when I heard other persons, who were with
him in the war, make mention of, and corroborate the very same
facts & circumstances, which he so often related to me, I can
have no doubt at this time, but that he rendered very important
services to his Country; he was very often in the Indian Wars
(He was on a campaign up on the Susquehanna river, at a place
called Shamokin, in a battle against the Indians, the top of his
head was shot off by a grape shot, I have seen his wound in the knee
and I suppose it would have required three, four, or five months to heal
up. my father told me all these circumstances before ever I saw
Samuel Fulton - and he Samuel Fulton, related afterwards to me the
very same facts. He was also wounded through the body near the
heart, & I believe in the foot or heel. I have often seen the scar of the
wound, His physician drew a silk handkerchief through his body
to bring out the clotted blood, I think it would have required six
months for the healing of this wound. He told me of many other
battles and skirmishes in which he was engaged, but I cannot now
remember all the facts, I believe I have seen the commission of
Capt. Samuel Fulton, he told me, he was a Capt. and others, who
were and with him also said he was a Captain. He lay a long time
in the Hospital. I lived his near neighbor from the year 1800. up to the

Mr. FREEDLEY, from the Committee on Revolutionary Pensions, made the following

REPORT:

The Committee on Revolutionary Pensions, to whom were referred the petition and papers of Catharine Fulton, of Washington county, Pennsylvania, report:

That this application was made to Congress January 6, 1846, and was referred to the Committee on Revolutionary Pensions, which committee, on the 27th of March, 1846, made a report favorable to the prayer of the petitioner, and reported a bill No. 338, which bill was passed by the House of Representatives, but was not concurred in by the Senate. Your committee, after a careful examination of the papers, concur in the report then made by the committee of the House, and make the same a part of this their report, as follows: "That the petitioner represents that she is the widow of Samuel Fulton, who was a captain of militia of the Pennsylvania troops. He was in the battle of Long Island, where he was wounded; at the battle of Brandywine, and at a battle of Staten Island; was marched to White Plains, and was also out in the Indian wars on the Susquehannah, and received a wound in the knee. She has frequently seen her husband's commission; but it is now lost. She was married to said Fulton on the 5th of May, 1785, who died the 13th of May, 1801; and she has not since married.

"James Proudfit swears that Fulton was a captain in the revolutionary army; that he was wounded in the knee; that he knew him well; and thinks he was in the service as much as three years.

"Aaron Cook swears that Fulton was in the revolutionary army, and was out in various tours of service—in all, seventeen or eighteen months.

"Leonard Wheatley swears that he knew Fulton while in the service; saw him at several different times during the war; and that he served not less than fifteen months.

"Samuel Fulton, a minister of the gospel, swears that he had seen the commission of Samuel Fulton, the husband of the petitioner, and knew it to be a captain's commission; that he had seen a wound in his knee; and believes he was also wounded in the side; believes he was in the revolutionary war five or six years.

"Margaret Medover swears that she repeatedly saw Fulton acting as a captain in the army of the revolution; but cannot specify the term of service.

"James Kerr testifies that it was believed by those who knew him, that he rendered important service during the war, &c., &c.

"The papers have been submitted to the Commissioner of Pensions, who says, 'that Fulton performed some service, there can be no doubt; but the evidence is not satisfactory as to the length of that service.' It is proved by the records in the office of the Secretary of State of the Commonwealth of Pennsylvania, that Fulton was a captain in the York county militia; and a pay roll in the same office shows that he did service in 1781.

"The marriage is proved by Robert Gemmell, James Proudfit, and the Rev. Samuel Fulton. The several persons testifying are certified by the proper officers to be of good character and entitled to belief.

"The committee have come to the conclusion that Fulton must have performed, at least, and very probably more than twelve months service; and they, therefore, report a bill granting his widow a pension for twelve months service as a captain, under the acts of 7th July, 1838, and 3d of March, 1843; and her pension to commence on the first of January, 1845."
