Dear Madam:

Reference is made to your letter in which you request the Revolutionary War record of Alexander Thompson, a pensioner of York County, Pennsylvania.

The data given herein were found in pension claim, W. 3623, based upon service of Alexander Thompson in the Revolutionary War.

Alexander Thompson was born in the year 1759, in York County, Pennsylvania; the names of his parents are not shown.

While a resident of Hopewell Township, York County, Pennsylvania, he enlisted in the fall of 1776, and served two months as private in Captain James Moffett's Pennsylvania company; he enlisted in the winter of 1777, and served two months under Captains Rhinedale and Caldwell; he enlisted in the fall of 1781, served as Lieutenant in Captain W. Collins' Pennsylvania company, stationed at Camp Security in York County, guarding prisoners, from which service he was discharged by Captain Fulton, *of two months* ~~and served two months.~~

He was allowed pension on his application executed January 28, 1833, at which time he was residing on the same farm in Hopewell Township, York County, Pennsylvania, which was his residence at enlistment in the Revolutionary War. Alexander Thompson died September 16, 1843.

The soldier married the first time, May 19, 1789, Ann Scott, who died June 10, 1797, at the age of thirty years and ten days. He married the second time, June 6, 1799, in Fawn Township, York County, Pennsylvania, Elizabeth Duncan, who was born June 6, 1772; they were married by a

Minister.

Elizabeth Thompson, the soldier's widow, was allowed pension on her application executed September 8, 1849, at which time she resided in Hopewell Township, York County, Pennsylvania; she was living there in 1855.

Alexander Thompson and his wife, Ann, had children, shown as follows:

Elizabeth Thompson	born	April	4,	1790.

Agness	"	October	6,	1794.

Alexander Thompson and his wife, Elizabeth, had children, shown as follows:

Ann	Thompson	born	August	15,	1800.

In 1855, Archibald Thompson, noted above, lived in Hopewell Township, York County, Pennsylvania.

In 1833, Andrew Duncan was High Sheriff of York County, Pennsylvania, at which time he made affidavit in behalf of the soldier's claim for pension; no relationship to the family was stated.

In 1854, Mrs. Mary Irvin and Andrew Morrison, both of York County, Pennsylvania, stated that they were present at the second marriage of Alexander Thompson.

In order to obtain the date of last payment of pension, name of person paid, and, possibly, the date of death of this pensioner, you should write the Comptroller General, General Accounting Office, this

city, and furnish the following:

The object of this letter is to ascertain whether a pension has been granted to Elizabeth Thompson (widow of Alexander Thompson who was a pensioner for revolutionary services) she having been married previous to the year 1800, and therefore entitled to a pension under the act of 1848

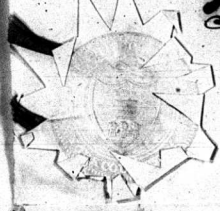
